

## **Data and contact to the Controller and Data Protection Officer**

The data controller is:

- Global Parks Poland Sp. z o.o. with registered seat at ul. Fosa 41/11, 02-768 – in case of purchase of tickets in our Water Park
- Moyome Sp. z o.o. with its registered seat at ul. Fosa 41/11, 02-768 – in case of purchase of accommodation in Suntago Village

**Purposes and legal bases** Personal data will be processed by us in order to:

1. proper implementation of the contract for the purchase of tickets or accommodation, including the identification of the client, handling the order form, making the reservation, realization of payments - pursuant to art. 6 clause 1 point b GDPR\* (data processing is necessary to perform the contract concluded with the customer in electronic form or to take action at the request of the data subject before the conclusion of the contract)
2. ongoing contact regarding the purchase made, handling possible complaints, verification of the right to discount tickets or determining special needs depending on the condition of the clients, as well as defense, exercise or establishment of claims - pursuant to art. 6 clause 1 point f GDPR (these objectives constitute the so-called legitimate interests of the controller)
3. performance of legal obligations related to accounting or tax law - pursuant to art. 6 clause 1 point c GDPR in connection with the provisions of tax law, the Accounting Act, concerning in particular data archiving for accounting purposes
4. sending marketing information, in particular our or our partners' offers, in electronic form or via phone calls - in accordance with the consent given to us - pursuant to art. 6 clause 1 point a GDPR. Consent may be revoked at any time, but without affecting the lawfulness of data processing before it is revoked

**Access of authorized persons and data recipients** Personal data will be disclosed to employees or associates of the Company, as well as to the following categories of recipients:

- entities providing support to the Company on the basis of commissioned services and in accordance with concluded data processing agreements, or
- entities authorized on the basis of legal provisions.

**Storage period** These data will be stored:

1. in the case of personal data regarding the concluded contract and transactions made within its scope - until the expiry of the limitation period for claims (6 years)
2. in the case of personal data processed for marketing purposes based on consent - until the consent is withdrawn.

**Your rights** Every person has the right to request from the us access to and rectification or erasure of personal data or restriction of processing concerning the data subject or to object to processing as well as the right to data portability. If we process your data based on your consent, you have right to withdraw consent at any time without affecting the lawfulness of processing. You have the right to lodge a complaint to the President of the Office for Personal Data Protection (address of the Office for Personal Data Protection: ul. Stawki 2, 00-193 Warsaw), if you consider that the processing of your personal data violates the provisions of the GDPR.

**Requirement to provide data and the consequences of not providing thereof** Providing personal data marked as required is necessary for the conclusion and implementation of the contract for the purchase of tickets. Providing other data is voluntary and failure to provide it has no negative consequences.
