CONTEST RULES: TASTE OF SUMMER WITH #MAMBASTYCZNAZABAWA

1. GENERAL PROVISIONS

- 1.1. These rules ("Rules") define the terms and conditions of the contest related to Suntago Water Park titled **TASTE OF SUMMER WITH #MAMBASTYCZNAZABAWA** ("**Contest**").
- 1.2. The organizer of the Contest is "Global Parks Poland" sp. z o.o., with its registered office in Warsaw, address: ul. Fosa 41/11, 02-768 Warsaw, entered into the Register of Entrepreneurs of the National Court Register maintained by the District Court for the Capital City of Warsaw, XIII Commercial Division of the National Court Register under KRS number 0000335329, NIP 7010192128, REGON 141926930, with share capital of PLN 1,000,000 ("Organizer").
- 1.3. The Contest is governed solely by these Rules, and all promotional materials are for informational purposes only.

2. CONTEST DURATION

The Contest runs from August 25th, 2025 (from the moment the contest post is published on Facebook) until September 7th, 2025 at 11:59 PM ("**Contest Duration**").

3. CONDITIONS OF PARTICIPATION

- 3.1. Any person over the age of 18 who registers their family to participate in the Contest may enter.
- 3.2. The participant must post a short description of their family's "mambastic" fun under the Organizer's contest post on the Organizer's Facebook page: https://www.facebook.com/go.Suntago.
- 3.3. Posting a comment is equivalent to consenting to (i) being contacted via private Facebook message and (ii) the publication of submitted materials as part of the Contest.
- 3.4. By posting, the participant confirms that:
- a) has read and voluntarily accept these Rules;
- b) agrees to and accept the terms of the Rules, including the prize collection procedure;
- c) will comply with the Rules and Facebook's terms of service;
- d) consents to the processing of personal data (name, surname, and shipping address) for Contest purposes;
- e) is a registered Facebook user.
- 3.5. The following individuals may not participate:
- a) Organizer's employees;
- b) persons involved in organizing the Contest;
- c) close relatives of the above, including spouses, ascendants, descendants, siblings, in-laws, adopted persons or their spouses, and persons in cohabitation.
- 3.6. Participation is free and voluntary.
- 3.7. The Organizer reserves the right to exclude participants who:
- a) post content that violates the law or Facebook's terms (especially offensive content);

- a) use accounts created in violation of Facebook's rules;
- b) use third-party accounts in violation of Facebook's rules;
- c) create fake Facebook accounts.

4. CONTEST COMMITTEE

To ensure proper organization and conduct of the Contest, especially to evaluate entries and select winners, the Organizer will appoint a Contest Committee ("**Committee**"). The Committee will consist of representatives of the Organizer. Decisions made by the Committee are final and not subject to appeal.

5. PRIZES

- 5.2. Prizes ("Prizes") for Winners:

- Professional photo session for a family of 4 (session at Suntago on a mutually agreed date, max.
 10 photos, no editing or retouching); Organizer transfers full copyright to the Winner;

- 5.4. Entry and photo session prizes must be redeemed by June 30th, 2026.

6. CONTEST PROCEDURE

- 6.1. Contest task and participation conditions:

 Participant posts a description of their family's "mambastic" fun under the Organizer's contest post on the Suntago Facebook page: https://www.facebook.com/go.Suntago.
- 6.2. Prizes will be awarded to participants ranked 1–10 by the Committee.
- 6.3. Contest results will be announced no later than November 21st, 2025 on Suntago's Facebook page.
- 6.4. Prize collection:
- a) Winners will be notified via private Facebook message.
- b) Winners must confirm receipt of the message and provide their address and phone number for prize delivery.
- c) Failure to collect the prize by December 31st, 2025 (including failure to provide necessary data) results in forfeiture of the prize and any related claims.
- d) Prizes will be sent at the Organizer's expense to the address provided by the Winner within Poland, within 14 business days of confirmation, via mail or courier.

7. PERSONAL DATA PROCESSING

- 7.1. The Organizer is the data controller of personal data provided by Contest participants.
- 7.2. Providing personal data is voluntary but necessary to participate.
- 7.3. Personal data will be processed solely for Contest administration and prize delivery.
- 7.4. Data will be stored only for the duration necessary to conduct the Contest and deliver prizes (no later than June 30th, 2026).
- 7.5. Participants have the right to access, correct, and delete their data.
- 7.6. Deleting data results in loss of eligibility to participate in the Contest.

8. COMPLAINTS

- 8.2. Complaints and questions must be submitted no later than June 30th, 2026, and should include information allowing identification of the Participant (name, surname, phone number or email address provided during entry) and the reason for the complaint.
- 8.3. Complaints and questions will be reviewed within 14 days of receipt, based on these Rules. Responses will be sent to the email address from which the complaint was submitted. If the Organizer requests additional information from the Participant, the 14-day period begins from the date the complaint is supplemented.

9. FINAL PROVISIONS

- 9.1. These Rules are available on the website www.parkofpoland.com in the "Regulations" section.
- 9.2. These Rules incorporate the applicable regulations of the Facebook platform.
- 9.3. The Organizer is not responsible for the unavailability of the Facebook website due to reasons beyond its control.

- 9.4. The Organizer reserves the right to verify whether Contest Winners meet the conditions specified in these Rules and in applicable laws. For this purpose, the Organizer may request specific declarations, data, or documents from the Participant, including address and contact phone number. Failure to comply with the Rules or legal requirements, or refusal to provide the requested information, will result in immediate disqualification and forfeiture of the Prize and any related claims.
- 9.5. The Organizer is not liable for:
- a) events preventing proper conduct of the Contest that could not have been foreseen or prevented, especially force majeure;
- b) failure to deliver the Prize due to the Participant not providing or incorrectly providing address details.
- 9.6. The Organizer is not responsible for any issues with telecommunications, data transmission, Internet network, Facebook platform, or third-party actions aimed at disrupting the Contest.
- 9.7. The Organizer is not liable for any failure or improper performance by Participants of obligations under these Rules resulting from their actions or omissions.
