

## REGULATIONS FOR CROCODILE ISLAND

### 1. GENERAL PROVISIONS

- 1.1. Crocodile Island is an integral part of the Jamango zone in Suntago Water Park and is subject to the rules derived from the General Regulations of Suntago Water Park and the General Regulations for the use of slides in the Jamango Zone (General Slide Regulations) and these regulations (Regulations).
- 1.2. Crocodile Island includes all attractions in the Jamango zone on the first floor between the Italian restaurant 'Va Bene' and the 'Sweet Corner' catering point.
- 1.3. To use the attractions in Crocodile Island, the Guardian must have a valid ticket to Suntago Water Park for at least the Jamango zone.
- 1.4. Some attractions require an additional fee. Detailed information is available at each attraction.

### 2. SAFETY RULES

- 2.1. Park personnel oversee compliance with these Regulations. All persons using the attractions in Crocodile Island are required to strictly follow the instructions of Suntago Water Park's personnel.
- 2.2. Children under 13 years of age may play in Crocodile Island only under constant supervision of parents or adult Guardians.
- 2.3. The Guardian of a child using the attractions of Crocodile Island must familiarize themselves with these Regulations, information boards, and Guest's instructions and enforce them on their guardianship.
- 2.4. Guests can enjoy Crocodile Island if they meet the age, height, and weight requirements indicated as permissible for each attraction, in accordance with the markings, including pictograms placed on the attraction.
- 2.5. In the case of attractions that specify the maximum number of the Guests at the same time, personnel may deny access to the further Guests for safety reasons.
- 2.6. Guardians are not allowed to enter the play structure. In case of a need to communicate with a Guest on the upper levels of the structure, assistance from Suntago Water Park personnel should be sought.
- 2.7. Guests of Crocodile Island must be completely dry and wear dry, anti-slip socks, regardless of the season. Failure to meet the dryness requirement allows Suntago Water Park personnel to deny services, including asking the Guest to leave the Crocodile Island area.
- 2.8. Guardians should ensure appropriate, movement-unrestricting clothing for minor Guests and remove jewellery, chains, glasses, and other decorations from the Guest.



- 2.9. The equipment in Crocodile Island should only be used as intended and with due caution. The attractions in Crocodile Island are sports equipment, and their use entails specific risks associated with sports activities, which the Guest assumes when deciding to use the play structures. As a result, there is a risk of bodily injury or injury, even when following regulations and Guest instructions. Suntago Water Park is not responsible for injuries or damage caused by improper use of the equipment.
- 2.10. Guests and their Guardians are prohibited from:
- 1) climbing on protective barriers,
  - 2) entering behind the play structure/attractions,
  - 3) sliding headfirst down the slides,
  - 4) jumping off the slides,
  - 5) improperly entering the slide and track,
  - 6) climbing up the slide incline, taking elements of the equipment out of Crocodile Island,
  - 7) modifying the structure (including attempts),
  - 8) jumping into the ball pool and mega block pool,
  - 9) entering areas not intended for general access,
  - 10) disregarding the instructions and guidelines of Suntago Water Park personnel,
  - 11) using birthday rooms without prior booking of the service according to the general rules in Suntago Water Park,
  - 12) bringing and consuming food products.
- 2.11. If a Guest has an accident in Crocodile Island, this must be immediately reported to Suntago Water Park personnel.
- 2.12. The use of tobacco products, e-cigarettes, alcoholic beverages and intoxicants is strictly prohibited in Crocodile Island. If Suntago Water Park personnel find that a person violates this ban, services may be denied to the Guest and their Guardian without the right to claim a refund. There is a total ban on the presence of persons whose behaviour suggests they are under the influence of alcohol or intoxicants in Crocodile Island. If it is found that a person's behaviour poses a threat to other Guests, that person, along with their ward, may be asked to leave Suntago Water Park according to the procedure described in the General Regulations of Suntago Water Park.
- 2.13. Good play rules, mutual respect, and courtesy apply in Crocodile Island. All Guests of Crocodile Island, i.e., Guardians and Guests, are treated equally.



### 3. LIABILITY FOR PROPERTY

- 3.1. The Guest or their Guardian is responsible for any damage caused by the Guest.
- 3.2. It is the duty of the Guardian and Guest to adequately secure their personal belongings. According to the General Regulations, Suntago Water Park operators are not responsible for items left unattended and are not liable for losses in this regard, such as damage or loss of jewellery, chains, decorations, glasses, and other items, regardless of their value.
- 3.3. Items found within Crocodile Island should be handed over to Suntago Water Park personnel. Found items will be issued to their owner after identification within 30 days from the date of finding. Detailed regulations are available in the General Regulations of Suntago Water Park.

### 4. RULES FOR ENTRY OF ORGANIZED GROUPS TO CROCODILE ISLAND

- 4.2. For events or special occasions, the prices determined when purchasing the appropriate package apply, according to the Regulations for the Use of Suntago Water Park by organized groups.
- 4.3. The Guardian of an organized group is responsible for communicating the content of these Regulations to all group members, i.e. Guests.
