REGULATIONS FOR THE PROMOTION "BLACK WEEKEND WITH SUNTAGO"

1. GENERAL PROVISIONS

- 1.1. These regulations ("Regulations") define the terms and conditions of promotional sale of tickets to Suntago Water Park conducted under the name of "Black Weekend with Suntago" ("Promotion").
- 1.2. Global Parks Poland sp. z o.o., with its registered office in Warsaw, address: Fosa 41/11, 02-768 Warszawa, entered into the Register of Entrepreneurs of the National Court Register kept by the District Court for the Capital City of Warsaw in Warsaw, XIII Commercial Division of the National Court Register under the number KRS 0000335329, NIP 701-019-21-28, REGON 141926930, share capital in the amount of PLN 500,000.00 is the organizer of the Promotion (the "Organizer").
- 1.3. The Promotion starts on 26 November 2021 at 00:00 and will last until 23:59 of 29 November 2021, but no longer than until the Ticket Pool specified in point 3.3 of the Regulations (the "Validity Period") is exhausted. The ticket purchased during the Promotion may be used on the day selected during the purchase process from the period ending on 31 December 2022.
- 1.4. The sale of the tickets under the Promotion is carried out in accordance with the Online ticket sales regulations available on the Organizer's website: <u>www.parkofpoland.com</u> (the "Website"), save as otherwise provided in these Regulations.
- **1.5.** The terms and conditions of the Promotion are specified only in these Regulations, and all information regarding the Promotion available in the advertising materials is for information purposes only.

2. CONDITIONS OF PARTICIPATION IN THE PROMOTION

- **2.1.** A participant to the Promotion is a Customer (as defined in Online ticket sales regulations available on the Website) who purchases an entry ticket to Suntago Water Park through the Website (the "**Participant**").
- **2.2.** By participating in the Promotion, the Participant agrees to the terms of the Promotion set out in these Regulations.
- **2.3.** Participation in the Promotion is voluntary and the Promotion is carried out on the territory of the Republic of Poland.

3. SUBJECT AND CONDITIONS OF THE PROMOTION

- **3.1.** Within the Promotion the Participant has an opportunity to purchase, during the Validity Period, an entry ticket to Suntago Water Park for a specific day from the Ticket Pool at 50% off the regular price.
- **3.2.** The Promotion applies only to entry tickets to Suntago Water Park purchased through the Website. The Promotion does not apply to tickets available at the ticket offices in Suntago Water Park or in any other way.
- **3.3.** The number of tickets available in the Promotion is limited to **20,000 (twenty thousand)** in total, regardless of the type and scope of the entry ticket (the "**Ticket Pool**").
- **3.4.** The Participant cannot pay for the tickets purchased within the Promotion with the Polish Tourist Voucher (*Polski Bon Turystyczny*).

- **3.5.** During the Promotion one Participant may purchase a maximum of 75 tickets in one transaction. It is forbidden to purchase tickets for the purpose of resale.
- **3.6.** The Promotion does not apply to tickets for the Suntago Bus and accommodation in Suntago Village or other services offered by Suntago Water Park.
- **3.7.** The Promotion cannot be combined with any other offers, discounts or promotions offered by the Organizer.
- **3.8.** The Participant cannot request a change of the entry date for which he/she purchased the ticket under the Promotion.
- **3.9.** Tickets purchased under the Promotion are not refundable or exchangeable for a different type of ticket, in particular, the Participant is not entitled to change the ticket purchased under the Promotion with regards to: (i) the date of entry; (ii) type of ticket (all-day ticket, 4-hour ticket, 2-hour ticket) (iii) scope of rights related to the ticket (limitation or extension of Suntago Water Park zones to which the guest has access).
- **3.10.** Pursuant to Chapter VII point 3 of the Online ticket sales regulations available on the Website and Article 38 item 12 of the Act as of 30 May 2014 on consumer rights, the Organizer informs that in relation to the ticket purchased via the Website entitling to access the Suntago Water Park within the contractually specified period the consumer is not entitled to withdraw from the contract concluded in this way.
- **3.11.** The Organizer has the right to cancel the transaction for the tickets purchased in breach of these Regulations.

4. FINAL PROVISIONS

- **4.1.** These Regulations is available on the website: www.parkofpoland.com.
- **4.2.** The remaining conditions of the online sale of entry tickets to Suntago Water Park and other information prescribed by law, including the rules for submitting complaints, are set out in the Online ticket sales regulations available on the Website.
- **4.3.** Each Participant is obliged to read these Regulations when ordering a ticket subject to the Promotion.
- **4.4.** In special cases, including when the security and/or stability of the Website is endangered, the Organizer has the right to temporarily stop or limit the Promotion, without prior notice to the Participants and carry out work aimed at restoring the security and stability of the Website. The Organizer will inform about difficulties related to the use of the Website for purchasing tickets during the Promotion by placing an appropriate message on the Website.
- **4.5.** The Organizer is not responsible for unavailability of the Website, which does not result from its fault.
