

## TERMS AND CONDITIONS OF THE "FOR STUDENTS" PROMOTION

## 1. GENERAL

- 1.1. These regulations ("Regulations") set forth the terms and conditions of the Suntago Water Park promotion ("Water Park" or "Suntago") under the name "FOR STUDENTS" (the "Promotion").
- 1.2. The organizer of the Promotion is "Global Parks Poland" spółka z ograniczoną odpowiedzialnością with its registered office in Warsaw, address: 41/11 Fosa Street, 02-768 Warsaw, Poland, entered into the register of entrepreneurs of the National Court Register kept by the District Court for the capital city of Warsaw in Warsaw, XIII Commercial Division of the National Court Register under KRS 0000335329, NIP 7010192128, REGON 141926930, share capital in the amount of PLN 1,000,000 ("Organizer").
- 1.3. The terms and conditions of the Promotion are specified only in the Regulations, and any information about the Promotion available in advertising materials is for information purposes only.
- 1.4. Tickets for the Promotion are sold only via the website of the Organizer: www.parkofpoland.com (the "**Website**"), in accordance with the relevant Suntago regulations, available at: www.parkofpoland.com/pl/regulaminy, subject to the other provisions of these Regulations.
- 1.5. The promotion cannot be combined with other offers, discounts, promotions or similar campaigns offered at Suntago, unless otherwise stated in the rules of the promotion.

# 2. PROMOTION PERIOD

2.1. Promotional Tickets can only be purchased between 1<sup>st</sup> of September, 2025 and 31<sup>st</sup> of October, 2025 (inclusive) for the period from 1<sup>st</sup> of September, 2025 to 31<sup>st</sup> of October, 2025.

## 3. TERMS AND CONDITIONS OF PARTICIPATION

- 3.1. Tickets purchased as part of the Promotion can only be used by natural persons aged 16 to 26 (according to date of birth) who additionally have the status of a student ("Participant").
- 3.2. The Promotion does not apply to visits to the Water Park on the basis of the following types of tickets and the purchase of tickets such as the following:
  - tickets purchased using discount codes, including discount codes shared by influencers;
  - tickets purchased as part of other promotions;
  - tickets purchased at the ticket offices of the Water Park and





- Tickets purchased with group bookings.
- 3.3. By participating in the Promotion, the Participant agrees to the terms and conditions of the Promotion set out in these Regulations.
- 3.4. Participation in the Promotion is voluntary.

#### 4. SUBJECT OF THE PROMOTION

- 4.1. The Promotion allows the purchase of all-day tickets to the Suntago Water Park to three zones (Jamango, Relax and Saunaria) with a 30% discount compared to the regular price from the current price list and to use them only by eligible Participants on the terms described below. ("**Promotional Ticket**")
- 4.2. To take advantage of the Promotion, after selecting tickets and adding them to the cart, enter the password student30 ("Promo Code") in the "You have a promo code" field and complete the order.
- 4.3. A person who wants to use the Promotional Ticket is obliged to present at the entrance to the Water Park, at the request of the Water Park staff, a valid document with a photo confirming that he/she meets the age criterion and the criterion of having the status of a student indicated in point 3.1 above. Failure to meet the age or student status criterion is associated with the obligation to pay an additional fee in the amount of the difference between the promotional price and the current regular ticket price.
- 4.4. A change in the type of ticket or the day on which the Promotional Ticket will be valid will require an additional payment of the difference between the regular price, i.e. in accordance with the price list in force on the day of making the change, and the price of the Promotional Ticket on the terms described in Chapter VII of the Online Ticket Sales Regulations.

#### 5. DISCLAIMERS AND EXCLUSIONS

- 5.1. The Promotion does not apply to Suntago Bus tickets and accommodation at Suntago Village or other benefits offered at Suntago that are not explicitly mentioned in the Regulations.
- 5.2. The Organizer has the right to refuse entry to the Water Park if:
  - the validity period of the Promotional Ticket has expired;
  - the person named on the Ticket or Promotional Ticket is unable to provide proof of age or student status.
- 5.3. The Promotional Ticket is not refundable or exchangeable for cash and does not entitle to any other benefits in the Water Park than those specified in the Regulations.
- 5.4. The Promotion cannot be combined with other offers, discounts and promotions offered by the Organizer, unless the rules of individual promotions state otherwise.





5.5. The Organizer reserves the right to refuse entry to the Water Park to a person who has violated the Regulations.

## 6. COMPLAINTS

- 6.1. Any questions and complaints related to the Promotion should be reported by e-mail to kontakt@parkofpoland.com.
- 6.2. The complaint should be submitted by 31<sup>st</sup> of December, 2025 at the latest and should contain data enabling the identification of the Participant (name, surname, telephone number or e-mail address provided in the complaint) and an indication of the reasons and grounds for its submission.
- 6.3. Complaints will be considered within 14 days of their receipt on the basis of the Regulations. Your response will be sent to the email address from which it was sent Reporting. If it is necessary for the Participant to supplement the complaint at the request of the Organizer, the 14-day period runs from the date of the Participant's supplementation of the complaint.
