

# **REGULATIONS OF THE "Benefit Plus - Lidl" PROMOTION**

#### 1. GENERAL

- 1.1. These Regulations ("**Regulations**") set forth the terms and conditions of the promotion at Suntago Water Park ("**Water Park**" or "**Suntago**") conducted under the name "**Benefit Plus Lidl**" ("**Promotion**").
- 1.2. The Organizer of the Promotion is "Global Parks Poland" spółka z ograniczoną odpowiedzialnością with its registered office in Warsaw, address: 41/11 Fosa Street, 02-768 Warsaw, entered into the register of entrepreneurs of the National Court Register kept by the District Court for Capital City of Warsaw in Warsaw, XIII Commercial Division of the National Court Register under KRS number 0000335329, NIP 7010192128, REGON 141926930, share capital in the amount of PLN 1,000,000 ("Organizer").
- 1.3. The Promotion Partner is Lidl sp. z o.o. sp. k. with its registered office in Jankowice at 48 Poznańska Street, Jankowice, 62-080 Tarnowo Podgórne, entered into the register of entrepreneurs of the National Court Register by the District Court Poznań-Nowe Miasto and Wilda in Poznań, VIII Commercial Division of the National Court Register under KRS number 0000597711, NIP: 781-18-97-358, REGON: 302821772 ("Partner").
- 1.4. The terms and conditions of the Promotion are set out in the Regulations only, and any information about the Promotion available in advertising materials is for informational purposes only.
- 1.5. This promotion cannot be combined with other promotions, offers, discounts available at Suntago.

#### 2. PROMOTION PERIOD

- 2.1. The promotion is valid from November 1<sup>st</sup>, 2025 to November 30<sup>st</sup>, 2025. ("Promotion Period")
- 2.2. A Promotional Code (as defined in clause 3) can only be downloaded during the Promotion Period.
- 2.3. The Promotional Code will be active from the day it is downloaded until December 31<sup>st</sup>, 2025. After this time, the Promotional Code will expire and you will not be able to redeem it. The Promotional Code does not entitle you to a discount on dates other than those indicated above.
- 2.4. A Promotional Code can be redeemed **for Tickets** (as defined in clause 4) entitling you to **enter the Water Park between November 1**st, **2025 and December 3**1st, **2025.**





## 3. TERMS AND CONDITIONS OF PARTICIPATION IN THE PROMOTION

- 3.1. The Promotion Participant may be a natural person who is a consumer within the meaning of Article 21 (1) of the Act of 23 April 1964 on the Civil Code (Journal of Laws of 1964 No. 16, item 93, as amended) and who has the Partner's appropriate application, who will additionally receive the opportunity to obtain one individual discount code in electronic form through the Partner's appropriate communication tools ("Promotional Code") and meet the terms and conditions of the Promotion described in these Regulations. ("Participant")
- 3.2. The rules for the eligibility of Participants to receive Promotional Codes are determined solely by the Partner, and the Organizer does not accept any responsibility in this regard.
- 3.3. By participating in the Promotion, the Participant agrees to the terms and conditions of the Promotion set forth in these Regulations.
- 3.4. Participation in the Promotion is voluntary.

## 4. SUBJECT OF THE PROMOTION

- 4.1. The Promotion entitles each eligible Participant to use a Promotional Code in connection with the purchase of a maximum of 2 tickets to Suntago Water Park ("Tickets") with a discount of 20% (in words: twenty percent, hereinafter referred to as the "Discount") in relation to the regular prices applicable in the Suntago Water Park for a specific day in the period from November 1st, 2025 to December 31st, 2025, as part of the availability of tickets and taking into account the opening days and hours of the Suntago Water Park.
- 4.2. The sale of services under the Promotion will take place exclusively through the Organizer's website: www.parkofpoland.com ("Website"), in accordance with the relevant Suntago regulations, available on the website: www.parkofpoland.com/pl/regulaminy, subject to the different provisions of these Regulations.
- 4.3. The possibility of using the Discount will apply to the two most expensive Tickets as part of a given transaction on the Website.
- 4.4. Tickets with Discount can be purchased: (i) to selected zones, (ii) with a selected length of stay within one day, (iii) on the same or different dates available, within the availability of tickets and taking into account the days and hours of the Water Park's opening for a specific day in the period from **November** 1<sup>st</sup>, 2025 to December 31<sup>st</sup>, 2025.





- 4.5. In order to take advantage of the Promotion, after selecting the Tickets and adding them to the cart, the Participant must enter the details of their Promotional Code in the "I have a promo code" field, and apply the Promotional Code by clicking on the "Apply" button and complete the order.
- 4.6. Tickets worth PLN 1 are excluded from the Promotion in accordance with the applicable price list made available on the Website.

#### 5. DISCLAIMERS AND EXCLUSIONS

- 5.1. The Promotion does not include tickets for organized groups and conferences or events.
- 5.2. The Participant should not transfer the Promotional Code to another person, as the loss or use of the Promotional Code by another person will mean that the Participant will not be able to redeem the Promotional Code.
- 5.3. A Promotional Code can only be used once. In the event that the Participant decides to purchase a ticket using a Promotional Code, it will not be possible to reuse the Promotional Code for another order.
- 5.4. Promotional Codes cannot be resold.
- 5.5. Promotional Code cannot be exchanged for cash.
- 5.6. The Promotion cannot be combined with other offers, discounts and promotions offered by the Organizer, unless otherwise results from the rules of individual promotions.
- 5.7. A change in the type of ticket or the day for which the Ticket with Discount will be valid will require an additional payment of the difference between the regular price, i.e. in accordance with the price list in force on the day of the change, and the price of the ticket purchased with the use of the Promotional Code on the terms described in Chapter VII of the Online Ticket Sales Regulations.
- 5.8. The Organizer reserves the right to refuse entry to the Water Park to a person who has violated the Regulations.

## 6. COMPLAINTS

- 6.1. Any questions and complaints related to the Promotion should be reported by e-mail, to the following address: kontakt@parkofpoland.com.
- 6.2. The complaint should be submitted by 30 January 2026 at the latest and should contain data enabling the identification of the Participant (name, surname, telephone number





- or e-mail address provided in the application) and an indication of the reasons and grounds for filing it.
- 6.3. Complaints will be considered within 14 days of their receipt on the basis of the Regulations. The reply will be sent to the email address from which the complaint was sent. In the event that the Participant needs to complete the complaint at the request of the Organizer, the deadline of 14 days runs from the date of the Participant's completion of the complaint.
