

**RULES OF THE BENEFIT PLUS PROMOTION - Lidl**

1. The Organizer of the Promotion is "Global Parks Poland" Sp. z o.o. Fosa 11/41, 02-768 Warsaw, entered into the Register of Entrepreneurs of the National Court Register, kept by the District Court for the m.st. of Warsaw in Warsaw, XIII Commercial Division of the National Court Register, under KRS number: 0000335329, NIP number: PL 7010192128, REGON number: 141926930, with a share capital of PLN 1,000,000, represented by Yotam Peleg, member of the management board ("**Organizer**").
2. **The "Benefit Plus" promotion (the "Promotion") is organised from 1 to 31 March 2025 and during this period the Member can download the Promo Code in the LIDL+ app, which can be used from 1 to 31 March 2025.**
3. The promotion entitles each eligible participant to purchase tickets to all three zones **of the Suntago Water Park located** in Wręcza (96-300) **at 1 Nowy Świat Street** with a discount of 15% (in words: fifteen percent) compared to the regular price from the current price list.
4. Eligible participant of the Promotion ("**Participant**"), i.e. a natural person who is a consumer within the meaning of Article 21 (1) of the Act of 23 April 1964 Civil Code (Journal of Laws of 1964 No. 16, item 93, as amended) will be given the opportunity to obtain one individual Promo Code in electronic form ("Promo Code") via the respective LIDL communication tools. The rules for qualifying participants for the Promotion are determined solely by LIDL and **the Organizer** does not accept any liability in this respect.
5. The Promo Code entitles the Participant to purchase **a maximum of 5 tickets** to Suntago Water Park **with a discount of 15%** (in words: fifteen percent) in relation to the regular prices applicable at Suntago Water Park **for a specific day in the period from 01 March 2025 to 31 May 2025**, subject to ticket availability and taking into account the opening days and hours of Suntago Water Park.
6. **Promo Code can only be used once.** If the Participant decides to purchase a ticket using a Promo Code, it will not be possible to reuse the Promo Code for another order.
7. The Promo Code will be active from the date it is downloaded or received by the Participant until March 31, 2025. After March 31, 2025, the Promo Code expires, and it will not be possible to use it. The Promo Code does not entitle you to a discount on dates other than those indicated above.
8. The Promo Code is not redeemable for cash.
9. **The Promo Code can only be redeemed online on the [www.parkofpoland.com](http://www.parkofpoland.com) website.**
10. To take advantage of the Promotion, the Participant, after selecting tickets and adding them to the cart, must enter the data from their Promo Code in the "I have a discount code" field and complete the order.
11. A Promotional Code is not a guarantee of the service selected by the Participant.
12. The Participant should not transfer the Promo Code to another person, as the loss or use of the Promo Code by another person will mean that the Participant will not be able to redeem the Promo Code.
13. **Promo Codes cannot be resold.**

14. The Promo Code cannot be combined with other offers, discounts, promotions or similar actions offered in the Water Park, unless otherwise stated in the rules of individual promotions.

A change in the type of ticket or the day for which the ticket was purchased with the use of the Promotional Code will require an additional payment of the difference between the regular price, i.e. in accordance with the price list in force on the day of making the change, and the price of the ticket purchased with the use of the Promotional Code and an administrative fee of PLN 10 for each ticket.**

18. The terms and conditions of the Promotion are set out exclusively in these terms and conditions, and all information about the Promotion available in advertising materials is for information purposes only.
