

Terms and conditions of the "Second ticket for 50%" promotion

1. GENERAL PROVISIONS

- 1.1. These terms and conditions ("**Terms** and Conditions") set out the terms and conditions of a promotion at Suntago Water Park ("**Water Park**" or "**Suntago**") run under the name "**Second Ticket for 50%**" ("**Promotion**").
- 1.2. The organiser of the Promotion is "**Global Parks Poland**" spółka z ograniczoną odpowiedzialnością with its registered office in Warsaw, address: ul. Fosa 41/11, 02-768 Warsaw, entered in the Register of Entrepreneurs of the National Court Register kept by the District Court for the Capital City of Warsaw in Warsaw, 13th Commercial Division of the National Court Register under KRS number 0000335329, NIP 7010192128, REGON 141926930, share capital of PLN 1,000,000 ("**Organiser**").
- 1.3. The Participant in the Promotion is Lidl sp. z o.o. sp. k. with its registered office in Jankowice at ul. Poznańska 48, Jankowice, 62-080 Tarnowo Podgórne entered in the Register of Entrepreneurs of the National Court Register by the District Court Poznań Nowe Miasto and Wilda in Poznań, 8th Commercial Division of the National Court Register under KRS no. 0000597711, NIP: 781-18-97-358, REGON: 302821772 ("**Partner**").
- 1.4. The terms and conditions of the Promotion are set out exclusively in the Terms and Conditions and any information about the Promotion available in advertising materials is for information purposes only.
- 1.5. The promotion does not combine with other promotions, offers, discounts available at Suntago.

2. PROMOTION PERIOD

- 2.1. The Promotion is valid from 1 June 2025 to 30 June 2025 (the "Promotion Period"). ("**Promotion Period**")
- 2.2. The Promo Code (as defined below) can also only be obtained and used during the Promotion Period.



3. CONDITIONS FOR PARTICIPATION IN THE PROMOTION

- 3.1. The Participant in the Promotion may be a natural person who is a consumer within the meaning of Article 21 (1) of the Civil Code of 23 April 1964 (Journal of Laws 1964 No. 16, item 93 as amended) and who possesses the relevant Participant's app, who additionally receives via the relevant Participant's communication tools the opportunity to obtain one individual discount code in electronic form ("**Promo0on Code**") and meets the terms and conditions of the **Promo0on** described in these Terms and Conditions. ("**Participant**")
- 3.2. The rules for qualifying Participants to receive the Promo Codes are determined solely by the Partner and the Organiser accepts no responsibility in this respect.
- 3.3. By participating in the Promotion, the Participant agrees to the terms and conditions of the Promotion as set out in these Terms and Conditions.
- 3.4. Taking advantage of the Promotion is voluntary.

4. SUBJECT OF THE PROMOTION

- 4.1. The Promotion entitles each eligible Participant to use the Promotion Code in connection with the purchase of any number of admission tickets at the regular price ("**Ticket**") and one ticket at a discount of (fifty percent) 50%. The price charged for the additional ticket will be equivalent to (fifty per cent) 50 per cent of the value of that ticket compared to the regular price from the current price list, on the terms and conditions described below ("**Discount**").
- 4.2. The possibility to use the Discount will only apply to one ticket ("**Discounted Ticket**").
- 4.3. A Discounted Ticket may be purchased for: (i) selected zones, (ii) with a selected length of stay within one day, (iii) on the same or different dates available, within ticket availability and taking into account the opening days and times of the Aquatic Park, with the Discount being calculated for the cheapest Ticket in the basket during the purchase process on the Website.

EXAMPLE:

- ⑨ Purchase of Tickets: Ticket1 at £185 and Ticket 2 at £70 - allows you to purchase Ticket 2 at a discount, i.e. at £35
- ⑨ Purchase of Tickets: Ticket1 at £185, Ticket 2 at £135 and Ticket 3 at £70 - enables the purchase of Ticket 3 at a discount, i.e. at £35



- 4.4. The sale of services under the Promotion will take place exclusively through the Organiser's website: www.parkofpoland.com (the "**Website**"), in accordance with the relevant Suntago regulations, available at: www.parkofpoland.com/pl/regulaminy, subject to the provisions of these Terms and Conditions to the contrary.
- 4.5. In order to use the Promotion, the Participant, after selecting the tickets and adding them to the basket, must enter the details from his/her Promotion Code in the "You have a Promotion Code" field and complete the order.
- 4.6. The Promotion excludes tickets with a value of PLN 1 in accordance with the applicable price list made available on the Website.

5. RESERVATIONS AND EXCLUSIONS

- 5.1. The promotion does not include tickets for organised groups and conferences or events.
- 5.2. The Participant should not transfer the Promotional Code to another person, as the loss or use of the Promotional Code by another person will mean that the Participant cannot redeem the Promotional Code.
- 5.3. Promo Codes cannot be resold.
- 5.4. The code is not exchangeable for cash.
- 5.5. The promotion does not combine with other offers, discounts and promotions offered by the Organiser, unless otherwise stated in the rules of the individual promotion.
- 5.6. A change of the type of ticket or the day for which the Discounted Ticket is valid will require payment of the difference between the regular price, i.e. the price in accordance with the price list valid on the day of the change and the price of the ticket purchased with the use of the Promotion Code according to the rules described in Chapter VII of the Rules and Regulations for Online Ticket Sales.
- 5.7. The organiser reserves the right to refuse entry to the Aquatic Park to a person who has breached the Rules and Regulations.



6 COMPLAINTS

- 6.1. All enquiries and complaints relating to the Promotion should be submitted by email to the following address kontakt@parkofpoland.com.
- 6.2. The complaint should be submitted by 30 July 2025 at the latest and should contain data enabling the Participant to be identified (name, surname, telephone number or email address provided in the application) and an indication of the reasons and grounds for the complaint.
- 6.3. Complaints will be processed within 14 days of receipt under the Terms and Conditions. A reply will be sent to the e-mail address from which the complaint was sent. application. In the event that the Participant has to supplement the claim at the request of the Organiser, the 14-day period shall run from the date on which the Participant supplements the claim.
