

# REGULATIONS of the PROMOTION "Mambastic Children's Day"

#### 1. GENERAL PROVISIONS

- 1.1. These terms and conditions ("Terms and Conditions") set out the terms and conditions of a promotion at Suntago Water Park ("Water Park" or "Suntago") run under the name Mambastic Children's Day ("Promotion").

Fosa 41/11, 02-768 Warsaw, entered in the Register of Entrepreneurs of the National Court Register kept by the District Court for the Capital City of Warsaw in Warsaw, 13th Commercial Division of the National Court Register under KRS number 0000335329, NIP 7010192128, REGON 141926930, share capital of PLN 1,000,000 ("Organiser").
- 1.3. The terms and conditions of the Promotion are set out exclusively in the Terms and Conditions and any information about the Promotion available in advertising materials is for information purposes only.
- 1.4. The promotion does not combine with other promotions, offers, discounts available at Suntago.

## 2. PROMOTION PERIOD

2.1. The Promotion is valid from 31 May to 1 June 2025 (the "**Promotion Period**"). ("**Promotion Period**")

## 3. CONDITIONS FOR PARTICIPATION IN THE PROMOTION

3.1. The Participant of the Promotion may be an individual who is under 16 years of age i.e. between 31 May and 1 June 2025. ("Participant") The Participant's age may be verified by the Organiser's staff on the basis of, for example, a school ID card or other document confirming the Participant's age, which the Participant wishing to participate in the promotion should present.

- 4.2. The promotion is open to the first 400 Participants who, between 31 May 1 June 2025 will enter the Suntago Water Park on a valid Ticket and participate in the "Mamba River of Adventure" game.
- 4.3. Promotion consists of an adequate number of tasks and verification of their completion by the animator/leader.
- 4.4. The prize for Participants in the Promotion is the opportunity to receive a "Gift" i.e. a gift pack from the sponsor "Mamba River of Adventures" and the Organiser.
- 4.5. The Participant's legal guardian can collect the Gift together with the Participant.
